

# DaVita Charitable Giving Frequently Asked Questions



## Question:

Who can submit charitable donation grants, and/or sponsorship requests to DaVita?

## Answer:

1. DaVita teammates a.k.a. employees (except for Patient and Referral Source Requests),
2. Patients, health care professionals, or health care entities,
3. Educational institutions, and
4. Community organizations that align with DaVita's Giving Pillars (other community requests can be made directly to a DaVita clinic or business office)

## Question:

What is the deadline to apply for a donation, grant, or sponsorship?

## Answer:

All donations, grants, and sponsorship requests must be submitted through one of the applications found on [davita.com/sponsorship](http://davita.com/sponsorship) at least one month in advance of the event or donation commitment deadline.

## Question:

What is the deadline to apply for a donation, grant, or sponsorship?

## Answer:

DaVita will not offer, provide, or solicit requests for donations:

- (a) With the intent to induce or reward referrals of patients;
- (b) In connection with a business arrangement; or
- (c) With the intent to influence patients' or potential patients' selection of DaVita as their healthcare provider.

All donations must:

- (a) Advance a genuine charitable or educational purpose;
- (b) Be made in response to a general solicitation to support an organization's fundraising activities, or to a broadly-disseminated solicitation to fund a specific activity; and
- (c) Be requested via one of DaVita's applications found on [davita.com/sponsorship](http://davita.com/sponsorship) or internally on VillageWeb for DaVita teammate requests.

DaVita will not provide donations:

- (a) To support the operational expenses of a referral source (this does not apply to charity event operating expenses related to an approved donation);
- (b) Requested by a DaVita teammate on behalf

**Question:**

What is the required supporting documentation for donation requests?

**Answer:**

All charitable giving requests must include a written explanation from the requestor outlining why the donation is being requested and how it will be used.

- (a) For teammate Donation requests, the requesting teammate must also submit documentation of manager approval (e.g., email).
- (b) For patient and Referral Source requests, the requestor's written explanation must be on the requesting organization's letterhead. The requestor must also submit documentation confirming that DaVita is not the sole sponsor or donor (e.g., emails requesting donations from other organizations).
- (c) For Medical Education Grant requests, the requestor's written explanation must be on the requesting organization's letterhead and must include a description of the proposed educational program, including the subject matter, date and time, location, proposed audience and expected number of attendees.

If the donation is to support an event, the requestor must also submit:

- (a) A list of other donors or sponsors
- (b) (b) A detailed agenda (e.g., flyer, schedule of events); and
- (c) (c) A detailed budget (e.g., Excel-style ledger showing event costs).

**Question:**

What is the payment timeline for approved requests?

**Answer:**

Approved and processed donations are paid out according to our grants management system (Benevity/American Online Giving Foundation) monthly disbursement schedule, on the 21st day of the month following when it was approved (e.g. a request that was approved on May 5 will be paid out on June 21). Please take this timeline into consideration when making requests.

Funding is sent directly to recipient organizations according to their preferences registered within Benevity. We encourage our nonprofit partners to sign up for electronic payments to avoid fees associated with traditional check processing.

**Question:**

What would increase my odds of being funded?

**Answer:**

Teammate (also known as employee) engagement is one of our largest considerations. Additionally, noting clearly defined impact metrics for your request on your application (ex: \$100 = 100 trees planted, \$1,000 = 250 children's books, etc).

**Question:**

What's the average amount of an approved request?

**Answer:**

While we do not have set limits, we typically like to start small (~\$5,000) with new partners and build upon the successes of teammate engagement and the initiative.
